



EDITORIAL POLICIES

1 Peer review policy

Every manuscript is peer reviewed by eminent reviewers. Reviewers are experts in their fields and provide an objective assessment of the manuscript.

2 Authorship

Papers should only be submitted for consideration once consent is given by the corresponding author. When a large group has conducted the work, the group should identify the individuals who accept direct responsibility for the manuscript. In this case, the corresponding author is taken as the responsible person for the manuscript.

3 Acknowledgements

All contributors who do not meet the criteria for authorship should be listed in an Acknowledgements section. Examples of those who might be acknowledged include a person who provided purely technical help, or a department chair who provided only general support.

4 Funding

ESA requires all authors to acknowledge their funding in a consistent fashion under a separate heading "Funding". If no funding is received for the study, authors should state that: "This research received no specific grant from any funding agency in the public, commercial, or not-for-profit sectors."

5 Declaration of conflicting interests

ESA requires a declaration of conflicting interests from all authors. Please ensure that a 'Declaration of Conflicting Interests' heading is included at the end of your manuscript, after any acknowledgements and prior to the references. If no conflict exists, please state that 'The Author(s) declare(s) that there is no conflict of interest'.

6 Research ethics and patient consent

Medical research involving human subjects must be conducted according to the World Medical Association Declaration of Helsinki. All papers reporting animal and/or human studies must state in the Methods section that the relevant Ethics Committee or Institutional Review Board provided (or waived) approval. Please ensure that you have provided the full name and institution of the review committee, in addition to the approval number. For research articles with human subjects, authors are also required to state in the Methods section whether participants provided informed consent and whether the consent was written or verbal. Approval number from the ethical committee is also required to be mentioned in the manuscript for studies based on animals.

PUBLISHING POLICIES

1 Ethics

ESA is committed to upholding the integrity of the academic record.

2 Plagiarism

ESA take issues of copyright infringement, plagiarism or other breaches of best practice in publication very seriously. We seek to protect the reputation of the journal against malpractice. Submitted articles may be checked with duplication-checking software for plagiarism. If found, manuscript may be denied publication.

3 Prior publication

If material has been previously published, it is not acceptable for publication in *ESA*.

4 Contributor's publishing agreement

Before publication, *ESA* requires a copyright certificate to be filled by the corresponding author on behalf of all the authors. Without this copyright agreement form, manuscript will not be published. Here the authors grants the exclusive right and licence to publish the full legal term of copyright.

5 Open access

ESA publishes the manuscript in open access where the papers are available online for the audience which can be downloaded freely.
